Request for Public Informational Meeting Dates

Dear Records Center:

Summit Carbon Solutions, LLC ("Summit Carbon") is developing an innovative carbon capture and storage project in lowa and four other states in the upper Midwest. Through this initiative, Summit Carbon is partnering with a number of ethanol plants in these states to capture carbon dioxide emissions that otherwise would be emitted into the atmosphere and transport those emissions through a pipeline to North Dakota where they will be permanently and safely stored in deep underground geologic storage locations. Summit Carbon anticipates the project will have the capacity to capture and permanently store 12 million metric tons of carbon dioxide every year. The pipeline required for transporting the liquified carbon dioxide, known as the Midwest Carbon Express, will cross 30 counties in the state of lowa. Summit Carbon, its participating ethanol producers, and other supporters are enthusiastic about bringing the economic and environmental benefits of this carbon capture and storage project to lowa, and to begin that process Summit Carbon is requesting informational meetings in the following list of counties.

To assist the Board in scheduling the public informational meetings, Summit Carbon proposes the following schedule, and has reservations for the listed locations which Summit Carbon believes meet the requirements of the Board's rules. Summit Carbon has attempted to take into account the Board's public schedule, and further to group counties for ease of travel. Most days include two meetings; there is one day (September 13) for which three meetings are proposed but the travel times are much shorter because the counties are near Des Moines.

Also of note, Summit Carbon proposes to make one of the meetings, on Monday September 20 in Mason City, Iowa, available for remote access. The availability of that option will be mentioned in the mailed notice for all of the meetings, with participation details to come later.

Summit Carbon is aware that it is customary to provide back-up or alternative dates. Because of the number of counties, specific back-up dates were not practical. Summit Carbon is also sensitive to the harvest schedule if the meetings run much later into the fall. However, the Summit Carbon team can generally be available as the Board needs to accommodate the Board's schedule in the last two weeks of October should any dates need to be adjusted.

Finally, Summit Carbon attaches with this letter (a) a current preliminary map of the project for illustrative purposes to give the Board a sense of the general locations and (b) a proposed draft of the template for mailed notices of the informational meetings. Also, Summit Carbon will provide to the Board a map of the notice corridor for the mailing within 24-hours of each county's mailing being sent, and a near-final draft of its proposed presentation materials by close of business on Monday, August 23, three weeks before the first proposed informational meeting.

If you have any questions, please let me know. To allow adequate time for mailed notice to be safely provided, Summit Carbon respectfully requests the Board issue meeting dates as soon as possible.
